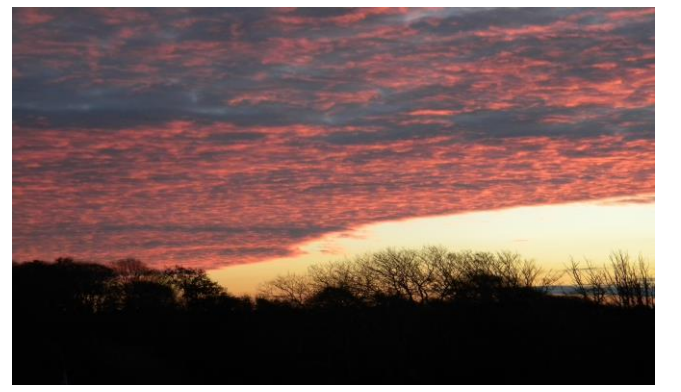

Upcoming Meeting Details

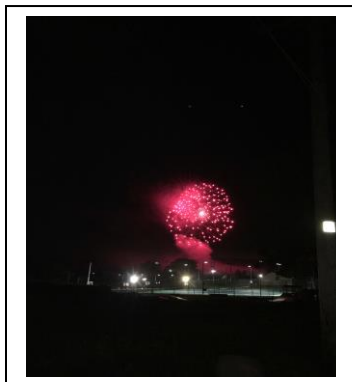
Executive Board Meetings are normally on the last Tuesday of the month at 7pm.
